MINUTES OF MONTHLY COUNCIL MEETING
JULY 13, 2011 at 8:00 P.M.
COUNCIL CHAMBERS AT MUNICIPAL BUILDING

A regular monthly Council Meeting of the Borough of Barrington was held on July 13, 2011, at 8:00 p.m. in the Council Chambers at the Barrington Municipal, with Council President Klaus presiding.

CALL TO ORDER: Council President Klaus called the meeting to order and made the following statement: "This meeting is held in compliance with Chapter 231 of the open public meetings act of 1975 and appropriate notice has been given. Notice of the meeting was filed with the Retrospect and Courier Post and also in the main office of the Borough Clerk where notices are currently kept.
