

BOROUGH OF BARRINGTON
MINUTES OF MONTHLY COUNCIL MEETING
AUGUST 11, 2010 at 8:00 P.M.
COUNCIL CHAMBERS AT MUNICIPAL BUILDING

A regular monthly Council Meeting of the Borough of Barrington was held on August 11, 2010, at 8:00 p.m. in the Council Chambers at the Barrington Municipal Building with Council President Klaus presiding.

CALL TO ORDER: Council President Klaus called the meeting to order and made the following statement: "This meeting is held in compliance with Chapter 231 of the open public meetings act of 1975 and appropriate notice has been given. Notice of the meeting was filed with the Retrospect and Courier Post and also in the main office of the Borough Clerk where notices are currently kept. He then led the salute to the flag of our country.

APPROVAL OF MINUTES: Council President Klaus noted that Council was provided with a copy of the printed minutes of the July 2010 meeting and asked if there were any corrections. Seeing no corrections, on a Motion by POPIOLEK and BERGERON the minutes of the July 2010 meeting were approved as submitted with all members of Council present in favor.

COMMITTEE REPORTS: The Municipal Clerk read a summary of the July 2010 monthly reports as submitted by the Police Department, Fire Company, EMS and Recycling. On a Motion by BERGERON and POPIOLEK all monthly committee reports submitted for July 2010 were approved to be received and filed with all members of Council present in favor.

PUBLIC HEARING TO CONSIDER REPROGRAMMING OF CDBG FUNDS: the Borough wants to reprogram funds from CDBG (YR 32) from street improvements along Trenton, Haines, Austin and Reading Avenues to Streets and Curb Improvements in the Stoneybrook Development. The Clerk explained that the streets originally planned are in an area that does not qualify under the CDBG guidelines. We performed our own survey of the residents in the area but the average incomes exceeded the limitations allowed therefore the funds have to be spent in the only section of Barrington that does qualify, that being Stoneybrook.

On a Motion by POPIOLEK and BERGERON the public hearing on the above was opened.

Seeing no comments from the public, on a Motion by BERGERON and POPIOLEK the public hearing on the above was closed.

Councilman Popiolek advised that WAWA is only interested if a traffic signal is approved by the state for the site. Iron Hill is coming in with or without the traffic signal. Councilman Popiolek thanked KEI Engineering for their ongoing work with the state for approval of signal.

LEN KEENAN, 124 Albany Ave., asked if notice could be put in next Communique and Ch. 19/33 discouraging cell phone use while driving. Council President Klaus advised that we could do both and advised that the deadline for the Communique is August 20.
