**MINUTES OF MONTHLY COUNCIL MEETING**  
**DECEMBER 16, 2010 at 8:00 P.M.**  
**COUNCIL CHAMBERS AT MUNICIPAL BUILDING**

A regular monthly Council Meeting of the Borough of Barrington was held on December 16, 2010, at 8:00 p.m. in the Council Chambers at the Barrington Municipal, with Mayor Rink presiding.

**CALL TO ORDER:** Mayor Rink called the meeting to order and made the following statement: "This meeting is held in compliance with Chapter 231 of the open public meetings act of 1975 and appropriate notice has been given. Notice of the meeting was filed with the Retrospect and Courier Post and also in the main office of the Borough Clerk where notices are currently kept. He then led the salute to the flag of our country.
