

**BOROUGH OF BARRINGTON**  
**MINUTES OF MONTHLY COUNCIL MEETING**  
**JANUARY 14, 2010 at 8:00 P.M.**  
**COUNCIL CHAMBERS AT MUNICIPAL BUILDING**

A regular monthly Council Meeting of the Borough of Barrington was held on January 12, 2010, at 8:00 p.m. in Council Chambers in the Municipal Building with Mayor John D. Rink presiding.

**CALL TO ORDER:** Mayor Rink called the meeting to order and made the following statement: "This meeting is held in compliance with Chapter 231 of the open public meetings act of 1975 and appropriate notice has been given.
