BARRINGTON TAKES THE LEAD ON CONSTRUCTION OF VEHICLE TRUCK WASH

In February, 2009, the DEP enacted regulations prohibiting the discharge of wash water from trucks, cars and other public works equipment because of the run-off into storm sewers. This meant that public works facilities could no longer wash their vehicles and equipment unless the discharge water was captured and prevented from running off into storm sewers. This presented a huge problem for municipalities. Mike Ciocco, Superintendent of Public Works, came up with a plan to solve this problem that would benefit not only Barrington, but surrounding communities as well. He proposed that a vehicle truck wash facility be constructed at Barrington Public Works that could be shared with three neighboring towns-Runnemede, Bellmawr and Mount Ephraim. With the blessing of Mayor and Council, Mike sent letters to the Mayors of the three towns and met with the Public Works Superintendents as well, asking if they would be interested in sharing in the cost of construction and operation of a vehicle truck wash that could be utilized by their public works departments for washing of vehicles, trucks and equipment. All four towns agreed, as this was a win-win for all of us and would bring us into compliance with the DEP Stormwater Regulations. With the assistance of the Borough Engineer, plans were developed for the vehicle wash system. The project went out for bids and the low bidder was Stormwater Compliance Solutions from Chester, NJ. The contract was awarded and the vehicle truck wash was completed in June of this year with a lot of the work being done by Barrington employee, Frank D'Intino, who installed the pressure washer system and connected the electrical, gas, water service, ventilation system, blow-down system and overhead boom. The asphalt improvements were performed by the Bellmawr Highway Department under the leadership of Joe Ciano with assistance from Barrington DPW employees. Employees from all four towns were trained on how to use the system and it is now fully operational. Total cost for construction was almost \$62,000 but because it was shared by the four towns, it only cost each town a little more than \$15,000. The four towns will share the annual operating costs as well. This is an excellent example of the money that can be saved and what can be accomplished when towns work together. Barrington has been a leader in shared services for many years and with Mike Ciocco's initiative and taking the lead on this project, four towns now have access to a state-ofthe-art vehicle truck wash facility that also brings us into compliance with DEP mandates. Job well done!





IN THE ZONE George W. Jones, Zoning Administrator

To: All Property Owners and Residents

If you have any Zoning or proposed construction questions contact George Jones, Zoning Administrator at 856-547-4040. Zoning Application has a fee of \$40.00. <u>There is no fee for handicap</u> ramps, but a Zoning Application must be made before you build. Ramps are temporary in nature and shall be removed when no longer required.

Important Information for 2011/2012

1. That you must complete a Zoning Application along with a copy of your plot plan (survey) to secure authorization and/or permits to: (applies to all commercial & residential districts) (prior to any construction projects)

- ~A. Erect a fence on your property; to include new or replacement of old fencing.
- ~B. Construct or erect a swimming pool {pools must be in a fenced yard, fence height four (4) feet (minimum) with self closing, self latching, lockable gates. Pools must be ten [10] feet from any property line or any structure
- ~C. To build an addition to your home. *All construction may require a drainage/grading engineer's plan & escrow.

- ~D. To add a deck to your home. *All construction may require a drainage/grading engineer's plan & escrow.
- ~E. Build, replace or rebuild your front porch, patios or steps, or add a handicap ramp.

~F. Erect a shed in your rear yard. Includes new or replacement. Must be five [5] feet from property lines

~G. Build a garage or accessory building or structure . *All construction may require a drainage/

grading engineer's plan & escrow

~H. Erect signs in a commercial zoning district (include color drawings). This includes replacing old signs. (Contractors signs must be removed as soon as work is completed.)

- ~I. Construct open or covered patios
- ~J. Construct driveways and aprons
- ~K. Operate a business in your home
- ~L. All Businesses must register at Municipal Building. For info call 856-547-0706
- ~M. Lot coverage is limited to 40% of the lot, includes all structures, pools, sheds, driveways & walk ways

2. That the following are not permitted in any **Barrington Zoning District**,

~A. The parking of vehicles on front, side or rear yards on unpaved impervious surfaces (Chapter 85) ~B. Keeping unlicensed or unregistered vehicles

on your property in any residential or commercial district (Chapter 95)

- ~C. Signs of any commercial venture or business in a residential zoning district (except for a real estate sign on the premises, the maximum size is six [6] square feet
- ~D. Duplex or two family homes in a residential district
- ~E. Off premises directional signs for a commercial business
- ~F. Business or commercial equipment parked or stored on streets in any district, must be behind the front corner of the building or house
- ~G. Operating a business in a residential district that has signs, more than one employee (this means property owner) and traffic to the property
- ~H. Sheds garages or other structures in the front or side yards
- ~I. Boats, trucks, trailers can be parked on driveway, past front corner of the house, into front yard area

4. Under 128-13. Definitions. Family; Five (5) or more persons related by blood, marriage or adoption, occupying a dwelling unit, living together and maintaining a common household, including not more than one (1) boarder, roomer or lodger. Not more than five (3) unrelated persons are permitted to occupy a dwelling unit; living together and maintaining a common household.

February caucus, Thurs., Feb. 9, at 7:30 and council, Tues., Feb., 14 at 8pm.

Recently adopted ordinances:
Ord. 972, Amending Chapter 91, Peace and Good Order. This ordinance changed the



curfew for minors to 10:30pm Sundays through Thursdays and to 12:00 midnight on Fridays and Saturdays.

• Ord. 974, Amending Chapter 91, Peace and Good Order. This ordinance removes any references to "Loitering" as it is pre-empted by state statute.

• Ord. 975, Approving the Acquisition of Certain Land. This ordinance approves the acquisition of a parcel of land on the White Horse Pike adjacent to the car wash for the White Horse Pike Redevelopment Project.

Ordinances scheduled for public hearing at the council meeting on Wed., Dec. 14 at 8pm:

• Ord. 976, Setting the Salary for the Chief of Police for 2011 (retroactive to January 1).

• Ord. 977, Amending Chapter 120, Vehicles and Traffic. This ordinance amends the parking restrictions on Kent Avenue, adds a parking restriction on Moore Avenue and removes the one-way restriction on Willmont Avenue.

SINGLE STREAM RECYCLING AND TRASH HOLIDAY SCHEDULE

As everyone should be aware of by now you can commingle your plastics, aluminum and bottles together with your mixed paper into one container for pick up on Thursdays or you can continue to separate as you have always done. You can now also recycle #'s 4, 5, & 7 plastics along with your # 1 & 2 plastics. All other numbered plastics are not accepted. Due to the Thanksgiving Day holiday falling on a Thursday recycle pick up will be done the following day, Friday, 11/25 the same day as trash. Please separate your recycle containers from your trash containers so the crews can easily distinguish between the two for proper pick up.

Concrete and Stump holiday schedule – Due to Thanksgiving Day falling on a Thursday concrete and stump pickup will be on, Wednesday, 11/23, please call prior to the pickup day to be put on the schedule.

Scrap Metal holiday schedule – Due to the Thanksgiving Day and Thanksgiving Day after, holiday falling on a Thursday and Friday scrap metal pickup will be on, Wednesday, 11/23. Please call prior to the pickup day to be put on the schedule.

Bagged and Containerized leaf holiday schedule – Due to Thanksgiving Day holiday falling on a Thursday bagged and containerized leaf pickup will be on Wednesday, 11/23.

Brush holiday schedule – Due to Marin Luther King, Jr. Day and President's Day falling on a Monday brush pickup will be the following day, Tuesday 1/17 and Tuesday 2/21/2012.

RECYCLING NEWS

Vegetative Waste/Leaves: During the Winter months from January until the end of March DPW will continue to do courtesy bagged or containerized pick ups weather and manpower permitting on Thursdays. This type of waste is recyclable and costs less to dispose of as compared to being disposed of as trash waste and is much more GREEN and environmentally responsible. If you can, please wait until the Spring regular pick up schedule resumes to put out. There will also be a loose-leaf pick up week that will occur in the Spring also.

Brush: Is a year round pick up performed on Mondays. Tree limbs and trimmings, brush with roots removed and stumps no larger than twelve inches in diameter will all dirt washed off. Stumps in excess of twelve inches in diameter must arrange for a special pick up which is performed on Thursdays by calling the DPW prior to Thursday to be put on a pick up list. Any tree removals performed by a contractor and/or homeowner is the responsibility of the contractor and/or homeowner to arrange for disposal of all resulting debris. The DPW will not pick up any debris resulting from the above mentioned.

Scrap Metal: Over the past few years the Borough has seen a steady decline in our recycling rate for scrap metal due to scavengers. In an effort to curb scavengers residents are asked to wait until the morning of pickup to put your items to the curb, you can also bring your scrap metal items to the DPW yard Monday thru Friday during normal business hours,

7:00 a.m. to 3:30 p.m., for disposal in our scrap metal dumpster or if you can contact the DPW ahead of time and we may be able to make arrangements for pick up prior to your regularly scheduled pick up date if our schedule and manpower allows. By increasing our scrap metal recycling rate the Borough will receive increased revenue shares, increase our overall recycling rate which will increase our recycling grant funding because it is based on how much you recycle and help in achieving the State goal of recycling 50% of our solid waste stream Statewide. In 2009 the Borough residential recycling rate was 53.71%.

Electronics Recycling: Effective immediately residents can begin to bring there E-Waste to the DPW yard for disposal. Hours for drop off will be Monday thru Friday, 7:00 a.m. to 3:30 p.m. The following items can be disposed of as E-Waste:

As of January 1, 2011, it is now mandatory to recycle covered electronic devices according to State Law entitled "The Electronic Waste Management Act". The Borough of Barrington DPW began accepting electronics in 2010 and recycled 3.30 tons for the year and we have recycled 10.61 tons so far in 2011. If residents have electronic items such as televisions that are to heavy or burdensome to drop off to the DPW please call and will make arrangements to pick up. Please be advised that any electronic items put to the curb for trash will not be picked up. Sidewalk Snow & Ice Removal Maintenance: Borough Ordinance requires that all homeowners and business owners remove snow and ice from the public sidewalks bordering there properties within (12) hours of daylight after snow and ice have formed. Don't get caught unprepared as storms come up quickly. Get your shovels and ice melt now and give the snow blower a start up so you are ready for old man winter.

Snow Removal: With winter fast approaching and the possibility of snow, residents need to be aware of several things. If your street is designated as a snow emergency route, which is sign posted no vehicles shall be parked on either side of the street once snow has accumulated and until snow has ceased and roads are plowed sufficiently to allow parking without being a hazard. If at all possible please park your vehicle off street even if your street is not an emergency route, this will allow for a more efficient snow removal job. Also the following streets are County Roads and are the responsibility of the County, Clements Bridge Road (CR573),
