

**ORDINANCE NO. 998**

**ORDINANCE OF THE BOROUGH OF BARRINGTON, COUNTY OF  
CAMDEN AND STATE OF NEW JERSEY AMENDING CHAPTER  
101, SEWERS, IN THE CODE OF THE BOROUGH OF  
BARRINGTON**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Barrington, County of Camden, and State of New Jersey, that Chapter 101, Sewers, is hereby amended in the Code of the Borough of Barrington, as follows:

**ARTICLE I.    ARTICLE II. Rates and Charges.    SECTION 101-20. Residential tax rates.**

**A.**    Home and apartment rates shall be as follows:

1. Single-family dwellings: two hundred ten dollars (\$224)
2. Two-family dwellings: four hundred twenty dollars (\$448)
3. Three-family dwellings: six hundred thirty dollars (\$672)
4. Four-family dwellings: eight hundred forty dollars (\$896)
5. Apartments shall pay an annual fee of two ten hundred dollars (\$224) per unit
6. Senior citizens and each unit of the Barrington Senior Housing: fifty eight dollars (\$66)

**ARTICLE II.    ARTICLE II. Rates and Charges.    Section 101-22.    Commercial  
and industrial tax rates.**

**A.**    Specific commercial and light industrial rates shall be as follows:

1.    Dry cleaners: three hundred ninety dollars (\$402)
2.    Luncheonette: three hundred ninety dollars (\$402)
3.    Gas station: three hundred dollars (\$312)
4.    Gas station with restroom: three hundred fifty dollars (\$362)
5.    Laundry room: one thousand dollars (\$1022)
6.    Tap room: eight hundred twenty dollars (\$900)
7.    Swim club: one thousand twenty dollars (\$1032)

**B.**    All other general commercial and light industrial rates shall pay an annual fee of two hundred ten dollars (\$224.00) per restroom.

**C.**    Industrial and manufacturing businesses shall pay a fee based on gallons of water consumed. Said consumption shall be based on the consumption billed by the water utility and shall be two dollars and ninety cents (\$2.95) per thousand gallons of water consumed. Billing shall be on a quarterly basis.

**ARTICLE III.**

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

**ARTICLE IV.**

This Ordinance shall take effect upon passage and publication according to law.
