 very prominent corner of 3rd Ave. and Clements Bridge Road has removed an eyesore and offered the opportunity to see the size of that property. The Owner/ Developer has approved plans for his property, but, unfortunately hasn't yet started the development. We will keep in contact with the owner to assist in the development.

Also demolished is the old Gravenor house, and we are watching for the redevelopment of the corner at Clements Bridge and Gloucester Pike. Both properties Gravenor and Para Plus have been purchased. We are awaiting formal contact from the new owners to see what plans are being proposed for the busy corner. If you are interested in any of these projects please don't hesitate to contact the Borough and or our Economic Development Committees for information.

Don't listen to rumors, get the information right from the source.

New Construction and Streetscape Work – We were afforded a loan from the Federal Government USDA Rural Development of \$2,044,000 with a low interest rate to assist with the reconstruction and demolition work within the borough's aging infrastructure. The reconstruction is along Thomas Ave. for rehabilitation of the sanitary

sewer and to construct the sump pump discharge system. The demolition will be to eliminate the pump station in front of the Willows Apartment Complex. This should save the municipality maintenance expenditures for this station approx \$ 10,000. annually.

The municipality has also been granted an additional \$ 539,000.00 to continue its Streetscape project, started 7-8 Years ago, from Williams Ave. to the border of Runnemeade. New curbing, lighting, trash receptacles and benches will connect the southern Clements Bridge corridor to the existing Streetscape along the downtown business district. We want to thank our municipal engineers, KEI Engineers, for their diligence in having the borough granted these funds to complete the long awaited streetscape.

Barrington A.B.L.E. Group -- this group of volunteers, made up of residents whose sole purpose is to assist their friends and neighbors in need. Answers, Benevolence, Liberation and Education--we help those in need to achieve each of these goals while on their way back to a normal life situation. We are currently extremely low in our food inventory due to the current economic demand. Also if you are willing to help, we desperately need donations of food, gift certificates

from local grocery stores, or donate your time as a volunteer. NOTE: If at all possible, Gift Certificates in denominations of \$10 or \$20 dollars will go along way with the bags of food we are distributing. PET LICENSES

Just a reminder that all pet licenses expired December 31. Renewal notices were sent out in early February. You have until April 30 to renew your license without a penalty. We need current rabies information in order to renew any license. We cannot renew a license for any pet whose rabies expires prior to October 31. If your pet's rabies will expire prior to October 31, you can get another vaccination ahead of time as it is not harmful to your pet. Check with your veterinarian to confirm.

To: All Property Owners and Residents; If you have any Zoning or proposed construction questions contact George Jones, Zoning Administrator at 856-547-4040, Zoning Application has a fee of \$40.00. There is no fee for handicap ramps; but a Zoning Application must be made before you build.

Ramps are temporary in nature and shall be removed when no longer required.

If you rent out your house, you must register with the Borough of Barrington.

IMPORTANT INFO
FOR 2014:
THE INTENT OF ZONING
IS TO PROTECT YOUR
PROPERTY

1. That you must complete a Zoning Application along with a copy of your plot plan (survey) to secure authorization and/or permits to: (applies to all commercial & residential districts) [Prior to any construction projects]

A. Erect a fence on your property; to include new or replacement of old fencing.

B. Construct or erect a swimming pool {pools must in a fenced yard, fence height four (4) feet (minimum) with self closing, self latching, lockable gates. Pools must be ten [10] feet from any property line or any structure

C. To build an addition to your home.* **All construction may require a drainage/grading engineer's plan & escrow.**

D. To add a deck to your home..* **All construction may require a drainage/grading engineer's plan & escrow**

E. Build, replace or rebuild your front porch, patios or steps, or **add a handicap ramp.**

F. Erect a shed in your rear yard. Includes new or replacement **Must be five [5] feet from property lines**

G. Build a garage or accessory building or structure .* **All construction may require a drainage/grading engineer's plan & escrow fees.**

H. Erect signs in a commercial zoning district (include color drawings)

This includes replacing old signs. [Contractors signs must be removed as soon as work is completed.]

I. Construct open or covered patios

J. Construct driveways and aprons

K. Operate a business in your home

L. All Businesses must register at Municipal Building. For info call 856-547-0706

M. Lot coverage is limited to 40% of the lot, includes all structures, pools, sheds, driveways & walk ways

2. That the following are not permitted in any Zoning District, of the Borough of Barrington

A. The parking of vehicles in front, side or rear yards on unpaved impervious surfaces [Chapter 85]

B. Keeping unlicensed or unregistered vehicles on your property in any residential or commercial

districts [Chapter 95]

C. Signs of any commercial venture or business in a residential zoning district (except for a real estate sign on the premises, the maximum size is six [6] square feet

D. Duplex or two family homes in a single family residential district

E. Off premises directional signs for a commercial business

F. Business or commercial equipment parked or stored on streets in any district, must be behind the front corner of the building or house

G. Operating a business in a residential district that has signs, more than one employee (this means property owner), and traffic to the property

H. Sheds garages or other structures in the front or side yards

I. Boats, trucks, trailers can be parked on driveway, beyond front corner of the house, in front yard area; but not parked in the streets

3. Under 128-13. Definitions. Family; Five (5) or more persons related by blood, marriage or adoption, occupying a dwelling unit, living together and maintaining a common household, including not more than one (1) boarder, roomer or lodger. Not more than three (3) unrelated persons are permitted to occupy a dwelling unit; living together and maintaining a common household.



Door-To-Door Solicitors— Important Notice

To all residents—it is important that all residents are aware that door-to-door solicitors must have a license to solicit in Barrington. All door-to-door solicitors have to complete an application process including a background check. Once they have been approved, they are issued a photo ID badge by the borough which they must have displayed at all times. If a solicitor knocks on your door, check to see if they have a photo ID badge issued by the bor-

ough. An example of what the badge looks like appears below. They may try to say that they have a photo ID badge from their company. **THIS IS NOT AN APPROVED BOROUGH ID BADGE!** If they do not have a photo ID badge from the borough, **CALL THE POLICE.** We want to make sure we have done everything we can to ensure that our residents are safe and that anyone knocking on their door to solicit has been approved to do so. Please—call 9-1-1 to report illegal solicitors.

Barrington Shade Tree Commission

Winter snows and weather seem to have created quite a mess with our lawns, bushes and possibly

our trees here in town. We imagine spring will tell us just how much damage has been done.

Streetscape Improvements

The Borough commenced with its Streetscape Improvement Project along Clements Bridge Road (Camden County Route No. 573) in 2002 which continued throughout the years. Phase 3 was completed in 2008. The projects were completed primarily with Federal Transportation Enhancement Funds administered through the N.J.D.O.T.

Since 2008, the Borough has applied for additional funding for the completion of the final phase from the NJ Turnpike to Reamer Drive/ Municipal Boundary.

In 2013, the Borough was successful in receiving \$539,000.00 in Transportation Enhancement Funding. Several meetings have been held with representatives of the N.J.D.O.T. Office of Local Aid and the design process has commenced.

When completed, Preliminary Plans will be on file in the Clerk's Office for review and comment and a Public Meeting will be scheduled soon to present the Preliminary Plans prior to their finalization.
