

**BOROUGH OF BARRINGTON
MINUTES OF MONTHLY COUNCIL MEETING
March 8, 2016 at 6:00 P.M.
COUNCIL ROOM AT MUNICIPAL BUILDING**

A regular monthly Council Meeting of the Borough of Barrington was held on March 8, 2016, at 6:00 pm in the Council Room at the Barrington Municipal Building, with Mayor Klaus presiding.

CALL TO ORDER: Mayor Klaus called the meeting to order with the following statement: "This meeting is held in compliance with Chapter 231 of the open public meetings act of 1975 and appropriate notice has been given. COMMENTS FROM MEMBERS OF THE GOVERNING BODY:

COUNCILMAN RINK – nice to see all here tonight, thank you for being here, it was a lovely day. Barrington Business Association meeting was February 25th, seventeen people attended, they are growing. They are looking at putting out goody bags with coupons and business cards. The BBA is speaking with Joe Gentile of Haddon Heights about a Farmers Market. Alyce Taylor presented on new tax laws and Darlene of “Sweetie Pie Boom Boom” brought in some goodies and is working on a program “cupcakes for cats” which will benefit the TNR program. The speakers were from Little League and Softball and were very informative, they are looking for sponsors for their teams.

Mayor Klaus advised that Softball and Little League each had their benefits in the last two weeks, keep them in mind and make donations to them if you can.

COUNCILWOMAN BERGERON – not much to report tonight. Barrington Basketball is doing well and the 6th grade team, her son Richard’s team, won for the first time ever! Thanks all for coming out tonight.

Mayor Klaus added that basketball is getting big in town; they have some really good coaches and sponsors.

COUNCILMAN LUDWIG – is trying to get American Water Company to test our water due to so much news about lead in water; waiting to hear back from them; nothing else to report tonight.

COUNCILWOMAN NICHOLSON – absent

COUNCILMAN ROBENOLT – thanks for coming out tonight. Please pay attention to road construction and give emergency people plenty of space. Keep Sean Cullen, the state trooper that died last night and his family in your prayers.

MAYOR KLAUS – on March 28th the county will conduct rehabilitation of Clements Bridge Road, it's been long coming. Tea21 streetscape will continue from the turnpike to the Runnemede border. The project will include sidewalks, curbing and repaving of Clements Bridge Road from Gloucester Pike to Haines Avenue, we hope it will be done by the end of September. A centennial meeting will be held March 17th at 6 pm in the Senior Center, please come out if you are interested in helping to plan our events. The Historical Society meets in the Senior Center on Sunday March 13th at 2 pm; they provide lots of good information at their meeting. Shoprite had lots of Barrington residents help last year at registers and with donations of money and buying tickets for the silent auction items and backed goods from their associates. They are looking for more assistance this year on Wednesday, March 16th at 2 pm. Barrington on Track will be going out soon; submission of articles is due by April 4th.

COUNCILMAN POPIOLEK – is very proud to present a proclamation to Natalie Hales recognizing her acceptance to West Point Military Academy. To gain admission, the high school senior had to meet certain academic and physical standards as well as receive a nomination from either the President or Vice President of the United States or a Member of Congress. Out of thousands of applications only about 9% are accepted. That is about 1,100 men and women from every state in the union and every race, religion and culture in the country. Natalie was also accepted at Annapolis but chose West Point.
