# BOROUGH OF BARRINGTON MINUTES OF MONTHLY COUNCIL MEETING SEPTEMBER 13, 2016 at 6:00 PM COUNCIL ROOM AT MUNICIPAL BUILDING

A regular monthly Council Meeting of the Borough of Barrington was held on September 13, 2016, at 6:00 pm in the Council Room at the Barrington Municipal Building, with Council President Popiolek presiding.

**CALL TO ORDER**: Council President Popiolek called the meeting to order with the following statement: "This meeting is held in compliance with Chapter 231 of the open public meetings act of 1975 and appropriate notice has been given.
