**AUTHORIZING A PERSON-TO-PERSON AND PLACE-TO-PLACE TRANSFER OF THE
PLENARY RETAIL CONSUMPTION LIQUOR LICENSE OWNED BY BARRINGTON
RESTAURANT, LLC TO WRG BARRINGTON, LLC**

WHEREAS application has been made to Mayor and Council for a person-to-person and place-to-place transfer of plenary retail consumption license No. 0403-33-003-011 owned by Barrington Restaurant LLC (pocket license) to WRG Barrington, LLC, (d/b/a Wild Wing Café at 270 White Horse Pike); and

WHEREAS the Governing Body submitted the application to the Chief of Police so that the appropriate background investigations could be completed; and

WHEREAS the Chief of Police conducted a thorough review of the application and supporting documentation in conjunction with investigators from the NJ ABC of all the principals who will be involved in ownership of the transferred license and finds as follows:

1. The application form and supporting documentation is complete.
2. The applicant is qualified to be licensed according to all standards established by statute, rules and regulations.
3. The applicant has disclosed the source of all financing obtained in connection with the licensed premises.
4. The Police Department has completed their investigation and finds that the transfer of license ownership to WRG Barrington, LLC, can be approved.

NOW THEREFORE BE IT RESOLVED by the Governing Body of the Borough of Barrington that the transfer of ownership of plenary retail consumption license No. 0403-33-003-011 from Barrington Restaurant, LLC, to WRG Barrington, LLC, is hereby approved; and

BE IT FURTHER RESOLVED that transfer of the pocket license to Wild Wing Café, 270 White Horse Pike, is also hereby approved; and

BE IT FURTHER RESOLVED that the Borough Clerk is authorized to endorse the transfer on the license certificate.
