

**BOROUGH OF BARRINGTON
MINUTES OF MONTHLY COUNCIL MEETING
OCTOBER 9, 2018 at 6:00 PM
COUNCIL ROOM AT MUNICIPAL BUILDING**

A regular monthly Council Meeting of the Borough of Barrington was held with Councilwoman Harris presiding.

CALL TO ORDER: Councilwoman Harris called the meeting to order with the reading of the Sunshine Statement. She then led all present in the Pledge of Allegiance.

ROLL CALL: The Municipal Clerk called roll of Council and with the following in attendance: Councilwoman Harris, Councilman Robenolt, Councilwoman Fawley and Councilman Beach. Mayor Klaus, Council President Ludwig and Councilman Popiolek were absent. Also on dais: Municipal Clerk Terry Shannon and Timothy Higgins, Esq.

APPROVAL OF MINUTES: Councilwoman Harris reported that council was provided with the minutes of the September 4, 2018, caucus and the September 11, 2018, council meetings and asked if there were any corrections. Seeing none, on a motion by Beach, second by Fawley, the caucus and council minutes were approved by all members of Council present with Councilman Robenolt abstaining on the caucus minutes as he was not present.

COMMITTEE REPORTS: The Municipal Clerk read a summary of the September 2018, monthly reports from the following departments: Police, Fire, EMS, Regional Fire Alliance, Construction, Tax & Sewer Collector, Court for the month of August and DPW Recycling. On a motion by Robenolt, second by Beach, the monthly reports were approved as submitted by all members of Council present.

On a motion by Robenolt, second by Fawley the public hearing was opened.

Clerk Shannon advised that the list will be maintained and will be distributed to the Police Department. Whenever someone comes in for a solicitor permit they will be given a copy of that list.

Bring your pre-made scarecrow to the Borough Hall parking lot between 10am-12 pm. We will give out ties for you to put your scarecrow on the telephone pole you will be assigned. Judging is October 22 when winners will be announced. Scarecrows will remain on the telephone poles until the weekend of November 3rd & 4th when

participants will be required to remove their own scarecrow. October 26 is the schools Trunk or Treat for pre-school through 8th grade and it is at Woodland School from 7-9 pm. Prior to that there will be "Pumpkin Pickin' with the Police" from 4-6 p, details will be out shortly. Trick or Treat is on October 31 from 3-8 pm and as Councilman Beach said please watch out for the running kids. The TNR town wide yard sale is October 20, proceeds benefit the TNR program.
