

BOROUGH OF BARRINGTON
MINUTES OF MONTHLY COUNCIL MEETING
March 12, 2019 at 6:00 PM
COUNCIL ROOM AT MUNICIPAL BUILDING

A regular monthly Council Meeting of the Borough of Barrington was held with Mayor Klaus presiding.

CALL TO ORDER: Mayor Klaus called the meeting to order with the following statement: "This meeting is held in compliance with Chapter 231 of the open public meetings act of 1975 and appropriate notice has been given. Notice of the meeting was filed with the Retrospect and Courier Post and is also posted in the main office of the Borough Clerk where notices are primarily kept. He then led the salute to the flag of our country.

ROLL CALL: The Municipal Clerk called roll of Council with the following in attendance: Councilwoman Harris, Council President Robenolt, Councilman Popiolek, Councilman Beach and Councilwoman Fawley. Also on dais: Mayor Klaus, Municipal Clerk Terry Shannon and Timothy Higgins, Esq. Councilman Ludwig was absent.

APPROVAL OF MINUTES: Mayor Klaus reported that council was provided with the minutes of the February 5, 2019 Caucus and the February 12, 2019 Council meetings and asked if there were any corrections or abstentions. Councilwoman Harris abstained from approval of the February Council meeting minutes. Seeing no further abstentions or corrections, on a motion by Fawley, second by Robenolt, the minutes were approved by all members of Council present.

COMMITTEE REPORTS: The Municipal Clerk read a summary of the February 2019, monthly reports from the following departments: Police, Fire, EMS, Regional Fire Alliance, Construction, Tax & Sewer Collector, DPW Recycling and January for Municipal Court. On a motion by Harris, second by Popiolek, the monthly reports were approved as submitted by all members of Council present.

Mike Ciocco, Supt. of Public Works – spoke about recycling single stream. The county is really pushing recycling; it does save the Borough money; there are rules and regulations to be followed. A list of “the dirty dozen” will be available; these are items people recycle that should not be recycled. Many residents are putting trash in recycling and recycling in trash. It's cheaper to recycle and we will be re-educating the public on recycling. We will have someone checking recycling and trash; sticker notices will be given if residents have not recycled properly.
