**RESOLUTION OF AGREEMENT BY AND BETWEEN THE BOROUGH OF BARRINGTON
AND ROSS BECK REGARDING EDUCATION BENEFITS**

WHEREAS the Borough of Barrington has in its employ Ross Beck (hereinafter, "Beck"), currently in the position of Public Works driver/laborer; and

WHEREAS Beck has expressed an interest in attending the Rutgers Certified Public Works Manager program; and

WHEREAS Beck has requested that the Borough pay for this program and allow him to attend during work hours on a strictly as-needed basis; and

WHEREAS Beck has agreed to reimburse the Borough any benefits received under this Resolution of Agreement should he leave the Borough's employ within five (5) years of completing the program (or any part thereof); and

WHEREAS the Borough Council of the Borough of Barrington has agreed to allow Beck to attend the Rutgers Certified Public Works Manager Program so long as this Resolution of Agreement is signed by all parties;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Barrington, that the request from Ross Beck to attend the Rutgers Certified Public Works Manager program, which would be consistent with and beneficial to his position with the Borough as a Public Works employee, is hereby approved; and

BE IT FURTHER RESOLVED that Beck agrees that if he leaves the Borough's employ within five years after completing the program (or any part thereof if leaves before program completion) he will reimburse the Borough for the cost of all benefits received under this Resolution of Agreement; and

BE IT FURTHER RESOLVED that the Mayor and Borough Clerk are authorized to sign this Resolution of Agreement with Beck.
