**Administration:**

- ◆ Oak Avenue speeding complaint—Haddonfield conducted the speed study and KEI evaluated and the results show there is not really a speeding problem on Oak. However, their commissioners still want to survey the residents about speed humps and they asked if we want to as well. Their thinking is that because the street is narrow and there are no sidewalks, residents may still want the speed humps. We do have funds available if the residents elect to have speed humps installed. Whether or not to send out the survey letter needs to be determined.
- ◆ Trash hauling and disposal bids—the consortium of towns received their bids for disposal and there was only one bidder which was Covanta. The prices we received from Seaside were actually better than their pricing so we will be awarding the trash contract to Seaside. Greg Fusco will submit a report and resolution of award will ready for the October agenda.
- ◆ Format for meetings—the Mayor wanted to discuss in-person vs. Zoom meetings with Covid escalating again. We need to know the decision for public notice purposes.
- ◆ Appointment of Assessor and Deputy Assessor—Brian Schneider is stepping down as our Assessor and has recommended that his deputy, Rich Buscemi, be appointed as Assessor and that Ron Breining be appointed as Deputy. This would be effective for October 1. Breining's resume is attached for your review. Resolution will need to be on council agenda.
- ◆ Ballot DropBox—the Board of Elections approved our location for a ballot drop-box in the parking lot. It will be installed in the next few months along with a surveillance camera—all of which will be paid for by the State.
