## FROM THE DEPARTMENT OF PUBLIC WORKS

**DPW HOLIDAY SCHEDULE THRU DECEMBER**

- October 12th (Monday)  
DPW is closed (Columbus Day)  
All services are rescheduled for Tuesday
- November 11th (Wednesday)  
DPW is closed (Veteran's Day)
- November 26th and 27th (Thursday and Friday)  
DPW is closed (Thanksgiving Day and Day After)  
Single Stream recycling and trash pickup will be performed on Friday, 11/27.
- December 24th (Thursday) DPW is closed (Christmas Eve), single stream recycling pick-up as normally scheduled.
- December 25th (Friday) DPW is closed (Christmas Day), Trash pick-up rescheduled for Saturday, 12/26.
- January 1st (Friday) DPW is closed (New Year's Day), Trash pick-up rescheduled for Saturday, 1/2.

**SINGLE STREAM RECYCLING AND TRASH HOLIDAY SCHEDULE**

As everyone should be aware of by now you can commingle your plastics, aluminum and bottles together with your mixed paper into one container for pick up on Thursdays or you can continue to separate as you have always done. #1, & #2 plastics only are accepted, all other numbered plastics are not accepted. Due to the Thanksgiving Day holiday falling on a Thursday recycle pick up will be done the following day, Friday, 11/27 the same day as trash. Please separate your recycle containers from your trash containers so the crews can easily distinguish between the two for proper pick up.

Concrete and Stump holiday schedule – Due to Thanksgiving Day and Christmas Eve holidays falling on a Thursday concrete and stump pickup will be on, Wednesday, 11/25 and 12/23. Please call prior to the pickup day to be put on the schedule.

**Scrap Metal holiday schedule** – Due to Thanksgiving Day and Day After and Christmas Eve and Christmas Day holidays falling on a Thursday and Friday scrap metal pickup will be on, Wednesday, 11/25 and 12/23. Please call prior to the pickup day to be put on the schedule

**Loose Leaf Pick Up** – The season will begin the week of October 5th and end the week of December 28th weather permitting. There are 3 districts which will have 4 pick up's each. Leaf signs will be posted the week prior to the districts scheduled pick up, you can also refer to the enclosed schedule listing, website or cable channel listings. Please place the leaves on the park strip between the curb and sidewalk. Do not put sticks, rocks or any other foreign debris in leaf piles, this can cause damage to the machines and create safety concerns for our employees. If foreign debris are left in the leaf pile, the leaf pile will not be picked up. Leaf crews will make one pass thru on your scheduled pick up week and will not return due to leaves being put out late. Leaves must be placed to the park strip by the beginning of your pick up week. Due to NJDEP storm water regulations and Borough ordinances, loose leaves are not to be placed within 10 feet of any storm drain inlet along the street. There will be no loose-leaf pick up the week of November 23rd due to the short holiday week. Pick up will resume the following week.

**Vegetative Waste/Bagged leaf Pick Up** – Vegetative Waste pick up will continue on Mondays during leaf season, you can also put out your bagged or containerized leaves along with your vegetative waste at the same time for pick up. Vegetative waste is defined as grass clippings, sticker balls, acorns, pinecones and viney type materials such as ivy, laurel and plant clippings. Vegetative waste can be put in 30-gallon containers not weighing more than 50 lbs. and/or contractor grade trash bags weighing not more than 25 lbs., please leave plastic bags untied it will allow the crews to move along much quicker. Please no dirt or sod. Blue vegetative waste containers can be obtained at the Borough Hall for a nominal fee. Due to the heavy volume your pick up may not be completed on the scheduled pickup day, just leave at curb and it will be picked up the following day.

**Brush** – Is a year round pick up performed on Mondays. Tree limbs and trimmings, brush with roots removed and stumps no larger than twelve inches in diameter with all dirt washed off. Stumps in excess of twelve inches in diameter must arrange for a special pick up which is performed on Thursdays by calling the DPW prior to Thursday to be put on a pick up list. Any tree removals performed by a contractor and/or homeowner is the responsibility of the contractor and/or homeowner to arrange for disposal of all resulting debris. The DPW will not pick up any debris resulting from tree removals.

**Scrap Metal** – In an effort to curb scavengers residents are asked to wait until the morning of pickup to put your items to the curb, you can also bring your scrap metal items to the DPW yard with an appointment, Monday thru Friday during normal business hours, 7:00 a.m. to 3:30 p.m., for disposal in our scrap metal dumpster or if you can contact the DPW ahead of time and we may be able to make arrangements for a pick up prior to your regularly scheduled pick up date if our schedule and manpower allows. By increasing our scrap metal recycling rate the Borough will receive increased revenue shares, increase our overall recycling rate which will increase our recycling grant funding because it is based on how much you recycle and help in achieving the State goal of recycling 50% of our solid waste stream Statewide. In 2019 the Borough residential recycling rate was 56.12%.

**Electronics Recycling:** Residents can bring their E-Waste to the DPW yard for disposal, please call prior to coming for an appointment. Hours for drop off are Monday thru Friday, 7:00 a.m. to 3:30 p.m. The following items can be disposed of as

As of January 1, 2011, it is now mandatory to recycle covered electronic devices according to State Law entitled "The Electronic Waste Management Act". The Borough of Barrington DPW began accepting electronics in 2010 and have recycled 140.42 tons since then as of the end of 2019. If residents have electronic items such as televisions that are too heavy or burdensome to drop off to the DPW please call and we will we make special arrangements to pick up. Please be advised that any electronic items put to the curb for trash will not be picked up. **Sidewalk Snow & Ice Removal Maintenance** – Borough Ordinance requires that all homeowners and business owners remove snow and ice from the public sidewalks bordering their properties within (12) hours of daylight after snow and ice have formed. Don't be caught unprepared as storms come up quickly. Get your shovels and ice melt now and give the snow blower a start up so you are ready for old man winter.

**Snow Removal** – With winter fast approaching and the possibility of snow, residents need to be aware of several things. If your street is designated as a snow emergency route, which is sign posted no vehicles shall be parked on either side of the street once snow has accumulated and until snow has ceased and roads are plowed sufficiently to allow parking without being a hazard. If at all possible please park your vehicle off street even if your street is not an emergency route, this will allow for a more efficient snow removal job. Also the following streets are County Roads and are the responsibility of the County, Clements Bridge Road (CR573), Gloucester Pike (CR659), Atlantic Avenue (CR727), Highland Avenue (CR573), Warwick Road (CR669), Hutchinson Avenue (CR665), Copley Road (CR666), 3rd Avenue (CR653), if you have any complaints please direct them to the Camden County Dept. of Public Works at 566-2980.

The following roads are State highways and are the responsibility of the NJDOT, I-295 and the White Horse Pike (SR30), if you have any complaints please direct them to the NJDOT maintenance yard at 1-800-768-4653.

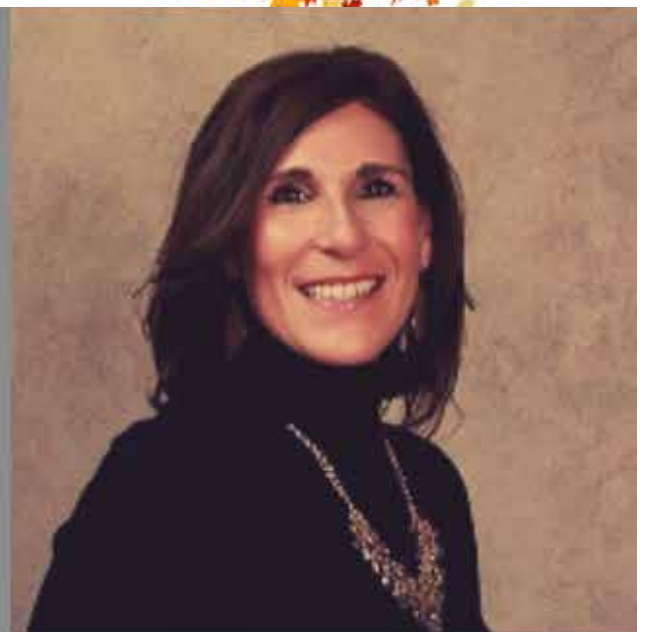

## IMPORTANT ELECTION INFORMATION

The general election will be Tuesday, November 3, 2020. This will be a **VOTE BY MAIL** election. All registered voters will receive a ballot in the mail. The Camden County Board of Elections will have all ballots mailed out by October 5. You are strongly encouraged to complete and return your ballot by mail as soon as you receive it. You also have the option of dropping it in one of the Dropbox locations throughout Camden County or you can bring it to your polling place on Election Day. If you bring it to your polling place, you will need to sign the election book and then your ballot will be placed into a security bag. All ballots will be returned to the Board of Elections after the close of the polls.

There will only be two polling locations for the general election in Barrington. Districts 1, 3 and 4 will be located at Borough Hall. Districts 2 and 5 will be located at Avon School. You will not be permitted to vote in a machine unless you are a handicapped voter who could not vote by mail. There will only be one machine at each polling location and they are only for handicapped voters who could not vote by mail. If you show-up to a polling location and want to vote, you will have to vote on a paper provisional ballot. That is why we strongly encourage you to Vote by Mail.

*The following information was provided by the Camden County Board of Elections.*

### **November 3, 2020 General Election Information per P.L 2020, c 70, 71 & 72**

Per the signing P.L. 2020, c. 70, 71, & 72 by Governor Phil Murphy, the 2020 General Election will be conducted primarily via Vote-By-Mail Ballots.

All Active registered voters will automatically be sent VBM Ballots, beginning the week of September 21st through October 5th. Following the initial mailing, anyone that newly registers will be sent a ballot soon after registration. All ballots will contain an instruction insert that describes how to vote the ballot (with pictures), how to return the ballot, drop box locations, and other pertinent information. If a voter needs a replacement ballot, for any reason, the voter can request a replacement ballot by visiting [www.camdencounty.com/vbm2](http://www.camdencounty.com/vbm2).

No Sample Ballots will be sent – a postcard will be sent instead with your Polling Place listed, the web address to find your sample ballot, drop boxes locations, etc.

There will be at least one Polling Place (Open 6:00am to 8:00pm) per Municipality and a minimum of 50% of its Polling Places (details to be determined by the Camden County Board of Elections BOE) where voters can only vote by Provisional (paper) Ballots. There will be a voting machine for the use only by disabled voters who are

unable to vote a paper ballot.

While a person can still only be a bearer of 3 ballots, that restriction is raised to 5 ballots if those ballots of immediate relatives residing in the same household.

If a voter submits a VBM or Provisional ballot and the BOE determines that it is to be rejected for a signature issue on the certificate envelope, the BOE must notify the voter. The voter is then given the ability to cure the signature and the ballot counted. All cures must be complete 48 hours prior to final certification.

### **Returning of the Voted VBM Ballots:**

- By Mail - ALL POSTAGE IS PAID (in Camden County postage is always paid). Mail at least a week before the election.
- By Drop-Box - There will be at least 13 Ballot Drop Boxes in Camden County (locations per the BOE). All Drop Boxes are available 24/7, are in well-lit locations, and are under video surveillance.
- In-Person to BOE in Blackwood – During normal business hours.
- In-Person at Polls - A voter may return only the VBM ballot that they personally voted to their designated Polling Place on Election Day, sign the Poll Book and place the ballot in a secure ballot box.

### **Deadlines:**

Deadline to REGISTER TO VOTE for the 2020 General Election – Oct 13th.

Deadline to REQUEST DUPLICATE BALLOT BY MAIL for a General Election Vote By Mail ballot – Oct 23rd so that a ballot can be mailed to a voter.

Deadline to REQUEST DUPLICATE BALLOT IN-PERSON for a General Election Vote By Mail Ballot – Nov 3rd by 8pm -- walk in to County Clerk's Office in Blackwood by 8pm on Nov 3rd to apply on the spot, get a ballot and turn it in to the BOE – all under one roof at the Election & Archives Center in Blackwood.

Deadline to mail or drop off your VBM ballot to be counted is Nov 3rd by 8pm at the BOE, polling place or place in a drop box. The BOE will consider ballots received after Election Day valid if (a) received from the USPS by 8pm Nov 10th with a postmark on or before Nov 3rd or (b) received from the USPS by 8pm Nov 5th without a postmark.

### **Election Vote Tallying and Results:**

• VBM Ballots will be counted first, starting up to 10 days prior to Election Day\*, and will continue daily through the Nov 10th deadline.

- In-person ADA machines will be tallied after close of polls.
- Provisional Ballots require verification after all VBM Ballots have been received, hence all in-person votes will be counted LAST.

\* While the BOE may begin counting VBM ballots prior to Election Day, it is a crime of the third degree for anyone to release results prior to the close of polls.

The "You Might have been raised in Barrington" Facebook site has been in existence since 2011. What do you think has been the most popular subject?

Ed & Ben's? Edmund Scientific? Fiberglass? Good guesses but If you didn't pick Culbertson School, you're wrong. The late, great school seems to be close to everyone's heart who grew up in our little burg.

Let's see if we can finish up the origin of our street names. Clement's Bridge Rd. is so named because it leads to Clement's Bridge where it crosses Timber Creek to Deptford Twp. Clement was a judge who lived in Haddonfield. Don't have much on Gloucester Pike but it does travel near to that city. Hobart Dr., Kent Ave., Mercer Dr., Peltoma Rd., were paper roads for 20 years before being developed in the early 1950s. Lawrence was the maiden name of Tommy William's wife. He built homes on that street around 1923. Lenton Ave. developer's name was Lenny. Letitia Lane was named this by the builder of the homes there. Little Lane was named for Rev. I. Walter Little who was the Methodist Church's pastor from 1944-1972. Lott Ave. was named for Raymond Lott who was mayor 1950-1955. Madison Ave. was named for Madison DuBois whose law firm did the legal work for Thomas Edwards. Thomas Williams' mother's maiden name was Moore and he built houses on Moore Ave. on his land. Nassau Dr. North & South was named by builders, Stein and Ridgeway, who liked the name. The name of Oak Ave. is obvious. Oakwood Rd. was named by developer Ruggles. Page Ave. was named after builder Percy Page. Pomona Rd. Is a continuation of the same street in Haddonfield. Russell Ave. was named for the brother of developer Thomas Edwards. Richards Ave. was named for Richard Edwards, son of Thomas Edwards. Shreve was the name of a farmer who owned much of the ground between Shreve and Williams Ave. Timber Dr. was named so by the developer. Thomas Ave. was named for Thomas Edwards. Trenton Ave. was named by the Barrington Syndicate in 1890. Warwick Rd. was named after a war hero Col. Warrick but the name got misspelled. Willmont Ave. is named for a member of the Wilmot family who owned the ground before development. Through some error, the name was changed. Williams Ave. named for the farmer and developer Thomas Williams. White Horse Pike was named for the White Horse Tavern in Stratford. Woodland Ave. was in a wooded area.

There is no information available for some streets. If your street hasn't been listed in this article or in previous ones, that's why.

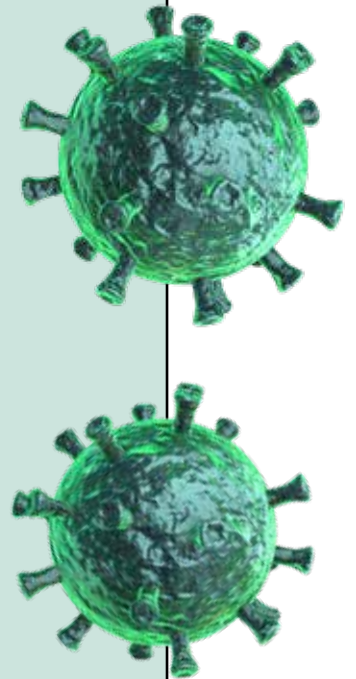
## Public Safety Minute

## PROPERTY MAINTENANCE INFORMATION

Property Maintenance is something the Borough takes very seriously. When we receive a property maintenance complaint, it is immediately sent to the Property Maintenance Officer for investigation. We have to follow our ordinance in terms of notice to the property owners. We thought it would be a good idea to explain to our residents the process for handling of property maintenance complaints.

- Complaint received—Property Maintenance Officer goes out to see the property.
- Seven day notice—a letter outlining the property maintenance violations goes out to the property owner of record. If the property is in the hands of a mortgage company, then the letter goes to the company. The letter gives them seven days to rectify the situation. We have to give them the seven days as part of due process as this is clearly spelled out in our ordinance.
- DPW Work Order prepared—after the seven days have elapsed, if the violations have not been abated, a work order is issued to Public Works so they can dispatch a crew to correct the violations. This normally involves grass cutting and shrub and weeds maintenance. This only applies to vacant properties. If the property is inhabited and the owner has not rectified the situation, then a summons to appear in court is issued.
- Property owner invoiced for charges incurred—an invoice is prepared for our costs incurred to maintain the property. Public Works provides the names of employees who performed the work along with the hours worked and costs for any materials that were purchased. An invoice is sent to the property owner.
- Lien imposed—if the property owner or the mortgage company fails to pay the invoice, a resolution is approved attaching a lien to the property for the amount of the invoice.

### STANDARDS FOR MAINTENANCE OF EXTERIOR PROPERTY

1. Unregistered and abandoned vehicles are prohibited in the street & on private property.
2. No vehicles are permitted to be parked on any lawns
3. All areas shall be kept free of uncontrolled overgrown grass, weeds, plant growth, and vegetation.
4. All areas shall be kept free of dangerously loose and overhanging tree limbs or dead trees.

These are just a few common items that normally generate the most complaints. We are asking our residents to please be patient as we are dealing with quite a few vacant properties and we have to follow the legal process. 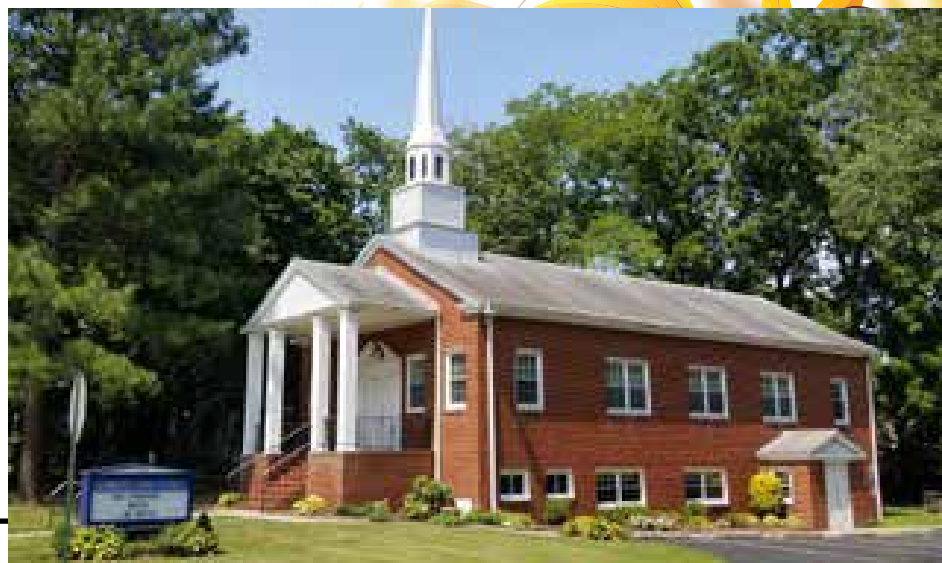
