- Aetna and Virtua agreed to a three-month extension of the current contract while negotiations are ongoing. There will be no interruption in medical coverage through March 31. Hopefully they will settle the contract by that date.
- Resolution designating deputy records custodians in various departments for council agenda.
- Resolution appointing Chris Mecca and Thomas El to four-year terms.
- Letter from Tim regarding amendment to zoning—new statute requires municipalities to amend zoning to include provisions for Electric Vehicle Supply/Service Equipment and Make-Ready Parking Spaces. Scott Smith from KEI is reviewing our zoning ordinance accordingly. Tim has prepared the model ordinance which after Scott has reviewed, this can be introduced at the January council meeting.
- Renewal of the shared services agreement with Camden County for Project Save.
- Renewal of the shared service agreements with the four towns for the Regional Fire Alliance.
- AFSCME members ratified the new contract on December 22. Resolution authorizing execution of the contract and the corresponding salary ordinance will be on the January 10 council agenda.
