

ORDINANCE NO. 1166

FIXING THE COMPENSATION OF CERTAIN EMPLOYEES OF THE BOROUGH OF BARRINGTON COVERED BY THE AFSCME, COUNCIL 63, LOCAL 3528, CONTRACT

BE IT ORDAINED, By the Mayor and Council of the Borough of Barrington as follows:

Section 1. The following represents the hourly rates and/or ranges for the respective employees of the Borough of Barrington, County of Camden, State of New Jersey, while in the employ of the Borough of Barrington. The compensation shall apply to those employees of the Borough of Barrington as of the effective date of this ordinance and shall be retroactive to January 1, 2023:

SECTION 2: Overtime shall be paid in accordance with the union contract as applicable thereto, when approved for payment by the Department Head.

SECTION 3: The compensation for the employees as herein designated shall take effect as indicated and shall apply thereto unless and until, the same have been changes as provided by law.

SECTION 4: All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed, but only to the extent of such inconsistency.

SECTION 5: Be it further resolved that these increases will increase by 5.0% in 2024 and by 3.5% in 2025 as provided for in the contract dated January 1, 2023, through December 31, 2025. The only exception will be those employees currently in a step program and their increases will be as provided for in their individual employment agreements.
