AUTHORIZING A SHARED SERVICES AGREEMENT WITH BELLMAWR FOR SEWER CONNECTIONS

WHEREAS the Borough of Bellmawr (hereinafter "Bellmawr") is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

WHEREAS the Borough of Barrington (hereinafter "Barrington") is a municipal entity organized under the laws of the State of New Jersey and located in Camden County; and

WHEREAS the properties located at 401 and 402 Fifth Avenue in Barrington had septic systems as Barrington does not have sewer services available in their area; and

WHEREAS the Borough of Bellmawr does have sewer services available in the area of these properties and has allowed both properties to connect to their sanitary sewer system; and

WHEREAS the Borough of Bellmawr will bill the Borough of Barrington for these sewer services and Barrington will bill the residents for said services accordingly; and

WHEREAS the Borough of Barrington and the Borough of Bellmawr wish to enter into a Shared Services Agreement pursuant to the New Jersey Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., relative to the providing of these sewer services by Bellmawr to the residents located at 401 and 402 Fifth Avenue in the Borough of Barrington; and

WHEREAS Barrington and Bellmawr intend, by virtue of the document attached hereto as Exhibit "A", to set forth the terms and conditions of this Agreement; and

WHEREAS Barrington, by virtue of the document attached hereto as Exhibit "A", wishes to authorize its proper and respective municipal officials to execute this Shared Services Agreement on behalf of the Borough of Barrington;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Barrington, County of Camden, State of New Jersey, that the Shared Services Agreement, pursuant to the New Jersey Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., by and between the Borough of Bellmawr and the Borough of Barrington, relative to Bellmawr providing sewer services to the residents of 401 and 402 Fifth Avenue in the Borough of Barrington be and hereby is approved; and

BE IT FURTHER RESOLVED that Patti Harris, Mayor of the Borough of Barrington, and Terry Shannon, Borough Clerk of the Borough of Barrington, be and are hereby authorized to execute the Shared Services Agreement, attached hereto as Exhibit "A," under the terms and conditions as set forth above; and

BE IT FURTHER RESOLVED that this Resolution will become effective upon the adoption of a similar Resolution by the Borough Council of the Borough of Bellmawr authorizing its Mayor and

RESOLUTION 2-2023-33

RESOLUTION REFERRING CERTAIN MATTERS TO THE BARRINGTON PLANNING BOARD FOR RECOMMENDATIONS AND REVIEW AND PURSUANT TO N.J.S.A. 40:55D-26 ET SEQ.

WHEREAS the Borough of Barrington is a municipal entity organized under the laws of the State of New Jersey and located in Camden County, New Jersey ("Barrington"); and

WHEREAS the Barrington Planning Board ("Planning Board") is an autonomous entity created by the Borough of Barrington pursuant to and governed by N.J.S.A. 40:55D-1 et seq.; and

WHEREAS N.J.S.A. 40:55D-26(a) requires that, prior to the adoption of a development regulation, revision, or amendment thereto, the Planning Board shall make and transmit to the governing body, within 35 days after referral, a report including identification of any provisions in the proposed development regulation, revision or amendment which are inconsistent with the master plan and recommendations concerning these inconsistencies and any other matters as the board deems appropriate; and

WHEREAS the Mayor and Borough Council of the Borough of Barrington wish to refer to the Barrington Planning Board, pursuant to N.J.S.A. 40:55D-26(a) et seq., the following issue for discussion as to enactment of appropriate ordinances addressing this item:

An Ordinance amending Sections 128-28 (F) (2) ((I) and 128-29 (F) (2) (I) in Article IV, Manufacturing Districts, in Chapter 128, Zoning, in the Borough Code. This ordinance establishes a prohibition on use or consumption of marijuana on the premises of authorized recreational marijuana retail facilities.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Barrington, that pursuant to N.J.S.A. 40:55D-26(a) et seq., the issue of amending Chapter 128 in the Zoning Code of the Borough of Barrington to prohibit use or consumption of marijuana on the premises of authorized recreational marijuana retail facilities, be and hereby is referred to the Barrington Planning Board for the action as required by statute.
