### **ORDINANCE NO. 1170**

OF THE BOROUGH OF BARRINGTON, COUNTY OF CAMDEN, STATE OF NEW JERSEY ADDING CHAPTER 52, COMMUNITY GARDEN, IN THE CODE OF THE BOROUGH OF BARRINGTON

**BE IT ORDAINED** by the Borough Council of the Borough of Barrington, County of Camden, and State of New Jersey adding Chapter 52, Community Garden, in the Code of the Borough of Barrington, as follows:

### ARTICLE I. SECTION 52-1 Establishment.

The Borough of Barrington hereby establishes "Barrington's Bounty," a community garden located at 4th Avenue and Austin Avenue in the Borough of Barrington. This community garden shall be under the care, custody and control of the Borough Council of the Borough of Barrington, to be managed by the Barrington Green Team

# ARTICLE II. SECTION 52-2. Rules & Regulations.

The community garden shall be governed by the Rules & Regulations promulgated by the Barrington Green Team, and the Community Garden Committee and may be amended from time to time as needed.

### ARTICLE III. SECTION 52-3 Garden Plots; Fees.

The Barrington Green Team shall allocate garden plots within the community garden on a first come, first served basis to qualified gardeners for a period of time commencing on April 15 through November 15 of the calendar year, to be known as the "Open Community Garden Season." Plots must be maintained by the gardeners throughout this season. The yearly fee for the plot within the community garden shall be \$32.00 for a single plot and \$60.00 for a double plot. These fees may be amended as necessary by Resolution of the Borough Council of the Barrington.

## ARTICLE IV. SECTION 52-4. Limitation of liability.

Gardener(s) agree to waive, release, indemnify and hold harmless the Borough of Barrington, its elected and appointed officials, the members of the Barrington Green Team, all of its affiliates, employees, agents, representatives, successors from any and all claims or causes of action, including but not limited to, personal injury or property damage, that may arise as a result of the participation of the gardener(s) in the Barrington Community Garden.

#### ARTICLE V.

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

ARTICLE VI.
This Ordinance
