**AWARDING A CONTRACT TO PIONEER GENERAL CONTRACTING COMPANY, INC.**

**BE IT RESOLVED** that the Borough of Barrington hereby recommends to the New Jersey Department of Transportation that the contract for "The Reconstruction of Austin Avenue – Phase 2, from Station 9+50 to Station 6+50 and Phase 3, from Station 6+50 to Station 3+35.5± in the Borough of Barrington, County of Camden, State of New Jersey (Partially Funded by the N.J.D.O.T. Municipal Aid Program, FY2022 and FY2023)" be awarded to Pioneer General Contracting Company, Inc. of Bradley Beach, New Jersey whose bid amounted to the total combined amount of \$294,415.00 (\$144,355.00 for Base Bid 'A' and \$150,060.00 Base Bid 'B'), subject to the approval of the Department;
