WHEREAS the Borough of Barrington is a municipal entity organized under the laws of the State of New Jersey and located in Camden County, New Jersey ("Barrington"); and

WHEREAS the legal name of the license applicant under which it is registered to do business in the State of New Jersey is "AACTPRO, LLC;" and

WHEREAS in 2020, New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS the Act establishes six (6) marketplace classes of licensed businesses, including Class 5 Cannabis Retailer License, for locations at which cannabis items and related supplies are sold to consumers; and

WHEREAS on July 13, 2021, the Borough of Barrington, by Ordinance #1145, approved the licensure of Class 5 Cannabis Retailer businesses in the Borough, while prohibiting all other types of licensed Cannabis businesses; and

WHEREAS on April 12, 2022, the Borough of Barrington, by Ordinance #1153, limited the number of licensed Cannabis businesses in the Borough to two (2) licensed Cannabis businesses; and

WHEREAS AACTPRO, LLC, made application to the Borough of Barrington for its support in obtaining from the New Jersey Cannabis Regulatory Commission, a Class 5 Cannabis Retailer License, to offer cannabis and cannabis products, obtained from licensed cultivators, manufacturers, and/or wholesalers, for sale to consumers in a retail store; and

WHEREAS the approval by the Borough of Barrington of the support sought by AACTPRO, LLC, in obtaining from the New Jersey Cannabis Regulatory Commission, a Class 5 Cannabis Retailer Business License did not exceed the number of Cannabis Business Licenses permitted under Ordinance #1153; and

WHEREAS pursuant to the regulations established by the Act, N.J.A.C. 17:30-5.1, an applicant for an annual cannabis business license shall include proof of local support in their applications, which shall be submitted as a Resolution adopted by the Barrington Borough Council; and

WHEREAS on May 22, 2023, the Borough Council for the Borough of Barrington adopted Resolution 5-2023-67, supporting the application of AACTPRO, LLC, to the New Jersey Cannabis Regulatory Commission, for a Class 5 Cannabis Retailer Business License to operate a Cannabis Retail Business within the Borough of Barrington's jurisdiction in accordance with Chapter 128-1 et seq. of the Borough Code of the Borough of Barrington; and

WHEREAS AACTPRO, LLC, has failed to take the necessary steps to create an appropriate facility needed to operate a Cannabis retail business and has not obtained from the New Jersey Cannabis Regulatory Commission a Class 5 Cannabis Retailer Business License; and

WHEREAS in light of the limitation in the Borough to two (2) licensed Cannabis businesses, Borough Council determines it to be in the best interests of the Borough to withdraw its support of AACTPRO, LLC, in obtaining from the New Jersey Cannabis Regulatory Commission a Class 5 Cannabis Retailer Business License, and seek to support other viable businesses in their efforts to obtain a Class 5 Cannabis Retailer Business License in the Borough;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council for the Borough of Barrington that the Borough of Barrington hereby rescinds Resolution 5-2023-67, thereby withdrawing its support of AACTPRO, LLC, in its application for a Class 5 Cannabis Retailer Business License, to operate within the Borough of Barrington's jurisdiction in accordance with Chapter 128-1 et seq. of the Borough Code of the Borough of Barrington.

RESOLUTION AUTHORIZING THE SIGNING OF A SHARED SERVICES AGREEMENT WITH THE BOROUGHES OF MOUNT EPHRAIM, OAKLYN, LAWNSIDE AND HI-NELLA FOR FIRE MARSHAL SERVICES

WHEREAS the Borough of Barrington entered into a Shared Services Agreement with the Boroughs of Mount Ephraim, Oaklyn, Lawnside and Hi-Nella for providing Fire Marshal services through the Barrington Regional Fire Alliance in April of 2011; and

WHEREAS said Shared Service Agreement has been automatically renewing annually and the language of the Shared Service Agreement has now been revised and a new agreement needs to be executed; and

WHEREAS in this economic climate, individual municipalities cannot take on fire marshal inspection services in a cost-effective manner without creating a burden for local taxpayers; and

WHEREAS the Borough of Barrington, as lead agency, has been operating the Regional Fire Prevention Alliance among the participating municipalities to provide fire marshal inspection services with the intent for the Alliance to be self-sustaining, thus eliminating any taxpayer burden; and

WHEREAS the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-4 et seq.) permits local units to enter into agreements for the provision of joint services and the Governing Body of the Borough of Barrington deems it to be in the best interest of the borough to continue to be the lead agency in this Shared Service;
