#### **Business:**

Ed fox reviewed the master plan starting with the Vision statement -diverse housing option and sustainable building practices. Goals- energy efficiency-Conservation & Open Space -prepare & ERI to identify & describe the Boroughs natural soils, water, vegetation, wildlife. Open space that makes the Borough eligible for funding. Goals & circulation- the circle, improve bus top signage, traffic measure on highland. Economic Development mixed used where appropriate Land Use- to get rid of new neighbourhoods wording. Community facilities & utilities -add a green development review checklist and guidelines. Renewable energy structure. Mr. Fox also went over regarding pollution, parking, bicycle trails. Economic development-changes along Clement's bridge road and the white horse pike. Home Occupation-working from home, conditional use, commercial zones, off street parking, landscaping. Ed went over the new definitions. Mr. Fox also spoke about mix/use and shared parking eating. Drinking establishments over 2,000 square feet exempt with the parking. Prioritize installation of public EV charging stations. Changing the zones for apartments. Ed answered a question from Mayor Hanson- can the Borough extend the D/C district to Atlantic Avenue to the overpass and said that there is no problem with that and give the opportunity for parking along the railroad tracks. Also, along Clement's bridge road commercial business should be no more than 2,500 square feet. Alex asked Mr. Fox about climate change in the master plan, Mr. Fox stated that is land use- plan use element. Chairman Rink spoke told Mr. Fox that we did advertise the meeting in the newspaper, we had a public hearing we had to open and close

because no one came out. When you have a public hearing, this now replaces the Master Plan if you didn't it is just a general recommendation, and your master plan would date back to 2001. Notice is required to hold public hearing on Master Plan Re-examination Report when said Report will amend the Master Plan. Michael lerino asked if we did advertise in the newspaper. Carol Fultano confirmed that the public hearing was advertised in the newspaper. Adoption of the Master Plan re-examination Report will amend the master plan. Board was advised that the agenda needed to be amended to include public hearing being held on the Master Plan Re-examination Report.
