**Administration**

Resolution to participate in Camden County contract for recyclables—the county has awarded a contract to Omni Recycling Group, LLC, and it is a ten-year contract with lower collection costs and a 10% revenue share. Per Mike Ciocco's analysis (attached), this past year we paid an average of \$77.55 per ton for disposal and there was no revenue share. The first year of the Omni contract will be \$35.00 per ton and there will be a CPI adjustment annually. They were substantially lower than the other bidders and we can participate by entering into a contract directly with Omni. Mike Ciocco and Councilman Beach both recommend we do this.
