**Administration**

Resolution for liquor license transfer—DELCO applied to transfer the former Chuck Lager license from WRG Corporation to Barrington Restaurant LLC and to make the license inactive. The police completed the background investigation and approved the transfer so the resolution to approve the transfer and deactivate the license will be on the council agenda.

Ordinance for smoke and CO detectors—the state is no longer requiring fire extinguishers on residential property sales or rental turnovers per statute so it is up to individual towns to adopt such ordinances. Common sense dictates that all homes and rental properties should have smoke/CO detectors installed in all bedrooms and a fire extinguisher so Fire Marshal Arpino is asking that we adopt an ordinance for this purpose.
