## **PUBLIC PORTION**

Mayor Hanson advised that if you have comments or questions, please come forward and state your name for the record. Public comment is limited to five minutes per person. On a motion by Beach, second by Drumm, the public portion of the meeting was opened.

Dawn Tilton - Barrington Mews resident's daughter. Several questions about Mews including open transparency, communication with the new owners, any communication, or proposals from new owners on transition, what is the current state of taxes on the mews property, are they paid to date? She then spoke about how much local affordable housing is for seniors in the surrounding towns and the raising of the minimum income amounts. The legal aid, thank you for that, but right now it is useless unless they are part of a giant lawsuit. Some residents are getting an automatic 1-year lease in their renewals, and they are being forced to sign. Ms. Tilton wants council to know what is going on with their constituents. Also, what about rental caps so there is protection for seniors? And what about the easement to the Mews to put up a sign, why help them when they don't help the residents. Mayor Hanson said we have not talked with the new owners yet. He spoke with Councilwoman Mercado last Friday and we will reach out to see if he will come meet with us with his and our attorney if he would like them present. The taxes for the property are paid up to date from the PILOT agreement, the new owner has not been billed for this year vet. Ms. Tilton wants to know if the deed is restricted to 100 senior and disabled residents, how will the borough enforce that? Mayor Hanson said we will discuss our options with our attorney as to how we will set that up.

Julie Goeltz – thank you for accepting my proposal and for your support of my purchase of the 219 Clements Bridge Road property.

Seeing no further comments from the public, on a motion by Drumm, second by Mercado-Miller, the public portion of the meeting was closed.

COUNCIL PRESIDENT BEACH – congratulations Julie, it's great to have someone from town open business in town, we appreciate it and will support you any way we can. Congratulations and thank you to Public Works, it is Public Works Week, they do a lot of amazing things for us throughout the year that most people don't see or notice. Happy Memorial Day to all, be safe and remember that the speed limit is 25 mph throughout the town, please pay attention to all the kids throughout town and to the crosswalks and speed signs.

MAYOR HANSON – congratulated Mrs. Goeltz on her new venture, we are happy to have you in town. The Barrington on Track was mailed out today, the second page has an article and explanation on your municipal, county and school taxes. I encourage you all to read it, so you are informed on where your money is going. Upcoming events include Memorial Day outside at 9am and indoors if it rains. The Pride Kickoff Event is tentatively scheduled for June 5 with more announcements that will be on social media when all is finalized. The Civic Association Block Party will be held at Deere Field on June 7. The summer recreation program is open for registration; the links are on social media and the website. July 3 will be our parade and fireworks, if you would like to join the parade you are welcome to do so, watch for more information. Lost World Park opening is pushed back and we hope to have it by mid-June. Mayor Hanson once again thanked our CFO Denise Moules for her work on the budget and for pinch hitting tonight as our clerk.
