

**ORDINANCE NO. 1215**

**ORDINANCE OF THE BOROUGH OF BARRINGTON, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AMENDING CHAPTER 145, CONSTRUCTION CODES, UNIFORM, IN THE CODE OF THE BOROUGH OF BARRINGTON**

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Barrington, County of Camden, and State of New Jersey, that Chapter 145, Construction Codes, Uniform, in the Code of the Borough of Barrington, is hereby amended as follows:

**ARTICLE I. SECTION 145-3. Construction Permit Fees.**

The fees as set forth herein are either added or amended. All fees not listed are retained in their entirety.

A. The Building Subcode fees shall be:

(4) Renovations, alterations, repairs and minor work fees.

(b) All other work:

[1] Estimated cost up to and including \$50,000 shall be \$30 per thousand dollars of estimated costs.

(6) The fee for the installation of residential roof mounted solar systems shall be \$300.00 per application.

B. The Electrical Subcode fees shall be:

(11) Solar Services.

(a) Service panel, service entrance subpanel; solar cabinets and inverters

[1] 200 AMP or less \$130

[2] From 201 AMP to 1,000 AMP \$165

[3] Greater than 1,000 AMP \$640

[4] Utility load management device \$45

[5] Photovoltaic systems. The fee shall be based on the designated kilowatt rating of the solar photovoltaic systems as follows:

[a] 1 to 50 kilowatts: \$65

[b] 51 to 100 kilowatts: \$129

[c] Greater than 100 kilowatts: \$640

[d] Combiners:

[1] 200 AMP or less \$65

	[2]	Greater than 200 AMP	\$129
[e]	Inverters:		
	[1]	10KW or less	\$65
	[2]	Greater than 10KW	\$129
[f]	Panels		
	[1]	1 to 50 panels	\$50
	[2]	Each additional 25 panels	\$15

### **ARTICLE III.**

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

### **ARTICLE IV.**

This Ordinance shall take effect upon passage and publication according to law.
