ORDINANCE OF THE BOROUGH OF BARRINGTON, COUNTY OF CAMDEN, STATE OF NEW JERSEY AMENDING ARTICLE V., SIGNS; SUPPLEMENTAL REGULATIONS, IN CHAPTER 360, ZONING, OF THE CODE OF THE BOROUGH OF BARRINGTON

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barrington, County of Camden, and State of New Jersey that Article V., Signs; Supplemental Regulations, in Chapter 360, Zoning, in the Code of the Borough of Barrington, is amended as follows:

Article V. Signs; Supplemental Regulations

ARTICLE I. ARTICLE V. SECTION 360-33 Projections into yards.

All required yards shall be unobstructed except as follows:

- A. The following shall apply to all districts:
 - (1) Retained in its entirety.
 - (2) Retained in its entirety.
 - (3) Retained in its entirety.
- (4) Swimming pools shall have a setback of at least ten (10) feet from any property line or structure. Swimming pools shall not be permitted in front yards. Swimming pools shall also conform to the State Uniform Construction Code.

ARTICLE II.

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

ARTICLE III.

BOROUGH OF BARRINGTON

The purpose of this Ordinance is to amend Chapter 360-33(A)4 to require swimming pools to have a setback of at least ten (10) feet from any property line or structure, and that swimming pools not be permitted in front yards, in the Zoning Code of the Borough of Barrington.
