Introduction of Sewer Rate Ordinance—Mayor Hanson and Denise will explain. The primary purpose is to eliminate the discounts that previously went to income restricted units. As many of the income restricted units have been eliminated, it is necessary that those units now pay market rates. Ordinance language is provided for your review.

Introduction of ordinance for towing services.
