

**ORDINANCE NO. 1223**

**ORDINANCE OF THE BOROUGH OF BARRINGTON, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AMENDING ARTICLE II. IN CHAPTER 285, SEWERS, IN THE CODE OF THE BOROUGH OF BARRINGTON**

**BE IT ORDAINED** by the Borough Council of the Borough of Barrington, County of Camden, and State of New Jersey, that Article II., Rates and Charges, in Chapter 285, Sewers, in the Code of the Borough of Barrington, is amended as follows:

<b>ARTICLE I.</b>	<b>ARTICLE II.</b>	<b>SECTION 285-1</b>	<b>Residential tax rates.</b>
-------------------	--------------------	----------------------	-------------------------------

A. Home and apartment rates shall be as follows:

- (1) Single-family dwellings: \$240.
- (2) Two-family dwellings: \$480.
- (3) Three-family dwellings: \$720.
- (4) Four-family dwellings: \$960.
- (5) Apartments shall pay an annual fee of \$240 per unit.
- (6) Condominiums shall pay an annual fee of \$240 per unit.
- (7) Senior citizens, disabled persons or surviving spouses who qualify for the New Jersey \$250 Senior Citizens and Disabled Persons Property Tax Deduction as provided in N.J.S.A. 54:4-8.41 et seq.: \$80. Applicants for this tax rate must be the owner of the subject property in whole or in part and provide evidence of ownership.

(8) Exempt veterans: \$80.

B. Exceptions.

- (1) Sewer charges shall be waived in their entirety for members of the military on active duty and deployed during wartime upon presentation of proper government-issued documentation confirming military status. Said military member must be the owner of the subject

property in whole or in part and provide evidence of ownership.

**ARTICLE II.**

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

**ARTICLE III.**

This Ordinance shall take effect upon passage and publication according to law.
