

ORDINANCE NO. 1243

ORDINANCE OF THE BOROUGH OF BARRINGTON, COUNTY OF CAMDEN, STATE OF NEW JERSEY AMENDING CHAPTER 339, VEHICLES AND TRAFFIC, OF THE CODE OF THE BOROUGH OF BARRINGTON

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barrington, County of Camden, and State of New Jersey that the Section 339-35 in Article XII of Section 339, Vehicles and Traffic, in the Code of the Borough of Barrington, is amended as follows:

ARTICLE I. ARTICLE XII. SECTION 339-35 Schedule I: No Parking.

In accordance with the provisions of Section 339-6, the following location is deleted from the list of locations previously designated as no parking areas:

Shreve Avenue	North	From a point 209 feet east of the easterly curbline of Clements Bridge Road (C.R. 573) to a point 118 feet east thereof

In accordance with the provisions of Section 339-6, the following locations are added to the list of locations previously designated as no parking areas:

Shreve Avenue	North	From a point 18 feet east of the easterly curbline of Clements Bridge Road (C.R. 573) to a point 70 feet east thereof
Shreve Avenue	North	From a point 152 feet east of the easterly curbline of Clements Bridge Road (C.R. 573) to a point 30 feet east thereof
Shreve Avenue	North	From a point 225 feet east of the easterly curbline of Clements Bridge Road (C.R. 573) to a point 130 feet east thereof
Shreve Avenue	North	From a point 465 feet east of the easterly curbline of Clements Bridge Road (C.R. 573) to a point 68 feet east thereof
Shreve Avenue	North	From a point 573 feet east of the easterly curbline of Clements Bridge Road (C.R. 573) to a point 60 feet east thereof
