

ORDINANCE NO. 1247

**ORDINANCE OF THE BOROUGH OF BARRINGTON, COUNTY OF CAMDEN AND
STATE OF NEW JERSEY TO AMENDING ARTICLE III TO CHAPTER 313,
TAXATION, IN THE CODE OF THE BOROUGH OF BARRINGTON**

BE IT ORDAINED, by the Borough Council of the Borough of Barrington, County of Camden, and State of New Jersey, that Article III. in Chapter 313, Taxation, is hereby added to the Code of the Borough of Barrington, as follows:

**ARTICLE III.
Cannabis Municipal Tax**

ARTICLE I. ARTICLE III. SECTION 313-12 Cannabis Municipal Tax.

A. Pursuant to Section 40 of the New Jersey Cannabis Regulatory, Enforcement and Marketplace Modernization Act (CREAMMA), a two percent (2%) municipal transfer tax shall be imposed on the lawful sale of cannabis by any Class I (wholesaler), Class II (manufacturer), Class IV (distributor), Class V (retail) and/or Class VI (delivery) license holder.

B. Pursuant to Section 40 of the New Jersey Cannabis Regulatory, Enforcement and Marketplace Modernization Act (CREAMMA), a one percent (1%) municipal transfer tax shall be imposed on the lawful sale of cannabis by any Class III (wholesaler) license holder.

ARTICLE II.

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

ARTICLE III.

This Ordinance shall take effect upon passage and publication according to law.

The foregoing ordinance was introduced by Mayor and Council at its regular meeting held on August 11, 2026. This Ordinance will be considered for adoption on final reading and public hearing to be held on September 8, 2026 at 6:00 p.m. in the Council Meeting Room, Barrington Borough Hall, 229 Trenton Avenue, Barrington, New Jersey.

The purpose of this Ordinance is to subject Class I, Class II, Class IV, Class V and Class VI cannabis businesses to a two percent (2%) municipal transfer tax, and Class III cannabis businesses to a one percent (1%) municipal transfer tax, permitted to be imposed by host municipalities on the lawful sale of cannabis pursuant to Section 40 of the New Jersey Cannabis Regulatory, Enforcement and Marketplace Modernization Act (CREAMMA).
